Excused Absence Policy: When necessary, make-up of course requirements missed because of student participation in University sanctioned events and activities shall be worked out between the instructor and the student upon the student's timely initiative. This policy governs academic disputes involving students. Such disputes most commonly arise as a result of student dissatisfaction with assigned grades, but students may also invoke the standards and procedures provided under this policy to challenge academic responses to instances involving alleged student academic misconduct or to challenge other decisions, justified on academic grounds, that affect their participation in or completion of university academic programs. Students who wish to challenge disciplinary actions taken after findings of academic misconduct must proceed under Board Policy No. 3:4. Course Description: Health Services Administration Abroad presents the formation and operation of public health care policies. This course emphasizes the relationship and impact of policy making to health care organizations and their services. Tactical issues of health services operations with a focus on achieving quality health care will be discussed.

Rationale: Health Services Administration requires a comprehensive understanding of health care issues and policies of the United States health care system. American Health Care is a unique system unlike any other industrialized country in the world. It is a fragmented system with Medicare, Medicaid, private insurance, Indian health, and military; these many parts to the U.S. system which is relatively young because the United States is a young country. These parts which make up the U.S. health care system are a result of influence from the worlds' oldest health systems models. A historical, legal, and ethical perspective lens is focused on access, need, and demand for health care services including policy analysis at the local, regional, and national levels to make economical and financial decisions. Ghanaian health care is also a relatively young system in a developing country rich with natural resources and a stable democratic government. Major U.S. health care systems and NGO's have invested in the health care system as part of global outreach. Students will participate and conduct research for a major health care system as part of this short-term study abroad program.

Course Goal: This course will provide an experiential and analytical in-depth study of Ghanaian Health Care in relation to United States Health Care on health policymaking and politics, including their impact on health administration and leadership. This faculty led program consists of lectures and

discussions, group activities, research, and project work. Assigned readings play a vital role in comprehension of the subject. Therefore, assigned reading must be finished prior to the mandatory pre-departure classes. These will be available through a live stream for students outside of 100-mile radius of campus. The emphasis of activities and projects will be on understanding how health leaders can approach the policymaking system and impact of population health on a global scale.

Required Readings: TBD and distributed by April 1, 2018

Instructional Methods and Activities: This course is a 3-credit course (45 educational contact hours)

1. **Presentations, Lecture, and Discussion/Participation** This course is presented via presentations (files can be accessed through D2L), lecture, and discussion/participation in a faculty-led program. See attached schedule
2. **Recommended Reading** Students will be assigned readings by the course instructor.

Learning Outcomes and Assessments: This course falls under the System-wide Graduation Requirements (SGR) goal of Expertise, with students focusing on one or more areas of in-depth study through their major and minor coursework, developing a level of expertise that will service them not only in their intended career but also as educated citizens. Successful completion of this course will result in student ability to:

1. Incorporate evidence-based leadership theory with cultural awareness to analyze health care cost, quality, disparities, and delivery/access based on political, ethical, and legal global influence.
 - Assessed through individual literature review of 1) Beveridge 2) Bismarck and 3) National Health System model compared to the health care systems in both the United States and Ghana.
 - Assessed through individual literature review of Ghanaian health care policy
 - Assessed through analysis of discussion questions related to the importance of ethics and social responsibility in business.
2. Identify tools such as predictive analytics, modeling, and simulation to improve risk management when applied to Ghana health care scheme.
 - Assessed through analysis of discussion questions related to the importance of ethics and social responsibility in predictive analysis.
 - Assessed through creation of survey instrument, in collaboration with faculty and Sanford World Clinics, distribute surveys and collect samples in various settings in Ghana. Initial analysis of data is also included. Strict adherence to research methodology and ethics is enforced.
 - Assessed through a white paper summarizing the research experience and a predictive analysis of meaningful use of the research.
3. Define challenges as a consequence of uncertainty and within a continuum of decision-making roles in refugee care, poverty and child development, HIV/AIDS community-based treatments, and international dealings in healthcare.
 - Assessed through individual assignment in these areas.
 - Assessed through analysis of discussion questions related to the importance of ethics and social responsibility in business executed abroad. Compare the Ghana's National Health Insurance Scheme (NHIS) to the unique United States health care system
 - Assessed through a case study analysis and presentation of assignment to peers on-site in Ghana.
4. Develop healthcare decisions based on legal, ethical, and policy guidelines.

- Assessed through the completion of a report submitted to the Dean regarding the learning experience.
- Assessed through reflection in a travel log/journal of experiences to incorporate into career enhancing perspectives.
