<u>Policy on Attendance</u>: Attendance is **vital** for success in the class. The student is allowed **three** unexcused absences. There will be no make-up exams or quizzes unless the student has a satisfactory excuse such as a death in the family, a family emergency, or illness. #### Instructional Style:

The class uses the flipped classroom approach. Students are expected to initially learn the material on their own at home. Class time will focus on clarification of principles and application. Since we will be traveling and in a compressed time-frame time, class time will be focused on clarifying questions and practice of the language.

- 5) Grammar: Students will be able to generally use tenses correctly and with good accuracy. The will understand basic sentence structure.
- 6) Culture: Students will understand the basics of the culture of the Spanish speaking world and realize that there is a wide range of cultures within it.

The student initiating the grade appeal should be prepared to show that the grade was decided unfairly. According to South Dakota Board of Regents Policy 2:9, any academic appeal must be initiated within thirty calendar days from the date that the student received notification of the grade, unless the grade is assigned within fifteen calendar days of the end of the term. In that case, any appeal must be initiated within fifteen calendar days after the start of the next term (fall, spring, or summer).
